This Membership Agreement (the "Membership Agreement") accompanies the Application for Membership and should be read in its entirety, signed and dated by applicable parties. This agreement should be returned with the Application for Membership.

In consideration of the membership privileges and participation in the benefits of the social and other activities of **Emerson Golf Club** (at times "Emerson," at times "the Club"), and the ability to use the club facilities and in further consideration of like commitments by other members on the membership roster, I/we have applied for membership in Emerson and subject to review and approval of membership application by Emerson, hereby agree to the following as conditions of membership:

- I/We have read the Rules and Regulations hereunder and agree to abide by and be bound by such rules and regulations throughout the life of this Membership Agreement.
- I/We understand that the rules and regulations of Emerson can be amended at any time by the management of Emerson and will abide by any such amendments.
- I/We acknowledge that Membership does not guarantee any continuing rights in or to use the Club facilities other than those specifically provided in the membership plan.
- I/We acknowledge that Membership in the Club is not an investment. I/We understand that I/we will not be entitled to voting rights, management rights, an equity interest or ownership interest in the Club or Club facilities.
- I/We herewith submit full payment of \$ _____ representing my 2010 Membership Fee, and understand that this annual membership is valid from _____ until 12/31/2010 (the "Membership Term").
- I/We understand that my annual membership fee is non-refundable. I have been advised that in the event that my membership is recalled or cancelled, my annual fee will be refunded at a pro-rated portion based on the date the membership agreement is executed, less any charges owed to the Club at that time.

RULES AND REGULATIONS

The management of Emerson Golf Club reserves the right to establish and amend all rules and regulations governing the operations of the Club, including rules regarding the use of the golf course and the grounds, all clubhouse activities, and the dress and behavior of members. Management shall have the right to enforce all of the rules and regulations promulgated by it. The failure of member or its guests to adhere to any of such rules may result in such member's suspension from the Club or revocation of his/her membership.

1. Membership

- (a) The Membership Term (the "Membership Term") shall be valid from the date of approval of Application for Membership for one full year or set forth under the said "Membership Agreement"
- (b) Members must be in good standing with all dues and other charges.
- (c) Not valid for tournament play.

2. Golf Rules and Regulations

- (a) More than 4 (four) persons will not be allowed to tee off under any conditions.
- (b) Children under the age of 15 years (a "Junior") are only permitted to play at twilight time accompanied by adult or under pro staff supervision (Identification of age is required).
- (c) A Junior is not permitted to drive a golf cart under any circumstances.
- (d) All players must wear soft spike golf shoes during play. NO metal spikes allowed.
- (e) Proper dress attire, including a collared shirt, is required. No jeans or sweatpants.
- (f) The Club's target time for 18 holes is 4 hours 15 minutes. Golfers should play "Ready Golf". Golfers should hit their shots when they are ready, even on putts and tee shots, so long as it does not interfere with other golfers.
- (g) Lightning is a major concern to the Staff and Management at Emerson Golf Club. In the event of lightning or other rapidly changing weather conditions, all golfers on the course should cease play, and immediately move toward safety.
- (h) Golf carts are not permitted on the driving range, beyond the white stake marks, greens, tee-boxes, nor parking area.
- (i) Golfers must have their own bag and set of golf clubs. Repair ball marks and replace divots.
- (j) Not allowed to bring outside food, alcoholic beverages or coolers.
- (k) Replay: Monday to Thursday: \$25.00, Friday:\$35.00, Weekend & Holiday:\$35.00

3. Reservations and Registration

- (a) Members must reserve a tee time.
- (b) Tee times may be reserved up to 21 days in advance through the Club’s website, www.emersongolfcourse.com, or by calling the Club at (201) 261-1100, or in person at the Pro Shop.
- (c) If Member reserved tee time and no show will charge regular green fees.
- (d) Members must register at the Pro Shop before beginning play.
- (e) To register, members must appear and present their membership card and a photo I.D. at the Pro Shop.
- (f) Membership cards are non-transferable.
- (g) Loss of membership cards must be reported immediately to the Pro Shop or office.
- (h) Appointments for Golf lessons can be scheduled at the Pro Shop or by calling the Club at (201) 261-1100.
- (i) Weekday and Twilight Members may not have the privilege of reserving tee times for Saturday, Sunday and Holidays, except after twilight.

4. Locker Rooms

- (a) Daily lockers are available for Members. Please inquire at the Pro Shop for details.
- (b) The Club is not responsible for any personal items, jewelry, or cash lost, stolen or left in the locker room.

I/We understand that the terms of this Membership Agreement shall be binding until the end of the Membership Term, as set forth in the Rules and Regulations, or until Emerson Golf Club terminates membership pursuant to the Rules and Regulations.
